A PROCLAMATION

Amendments to Sections 8 and 14 of the Regulations
of the Game Law.

The following resolution, dictated by the Commissioner of Agriculture and Commerce, by virtue of the faculties vested in him by Section 7 of Act No. 374 approved on May 11, 1950, as amended, is hereby approved and promulgated pursuant to the provisions of the aforesaid Section by means of this proclamation, for the information and guidance of all concerned.

R E S O L U T I O N

Amendments to Sections 8 and 14 of the Hunting
Regulations

Sections 8 and 14 of the Hunting Regulations promulgated by virtue of Act No. 374 approved on May 11, 1950, as amended, are hereby amended to read as follows:

Section 8. Open Seasons: Game birds and animals may be hunted during the following seasons which will include both dates specified.

(a) Native and migratory water fowl.....
may be hunted during the season fixed annually by the Secretary of the Interior of the United States for the hunting of migratory water fowl.

(b) Doves..... from the second Sunday of July to the fourth Sunday of October.

(c) Pigeons..... from the second Sunday of July to the fourth Sunday of October.

(d) Wild pigs and goats on Mona Island..... throughout the entire year.

Section 14. Game Sanctuaries: It is strictly prohibited to hunt, molest, or destroy birds or their nests in the following areas, which are hereby declared to be Birds Sanctuaries:

- (b) Guajataca Lake
- (c) Guayabal Lake
- (d) Carite Lake
- (e) Guineo Lake
- (f) Doña Juana Lake (Matrullas)
- (g) Maricao Insular Forest
- (h) Guánica Insular Forest
- (i) Guilarte Insular Forest
- (j) Susúa Insular Forest
- (k) Guajataca Insular Forest
- (l) Río Abajo Insular Forest
- (m) Carite Insular Forest
- (n) Caribbean National Forest
 - (1) Toro Negro Division
 - (2) Luquillo Division
- (o) Cambalache Experimental Forest
- (p) San Juan Mangrove Swamps
- (q) Ceiba Mangrove Swamps
- (r) Boquerón Mangrove Swamps

- (s) Quintín Lagoon, Puerto Nuevo, Vega Baja
- (t) Lake Cidra
- (u) Lake Caonillas
- (v) Vega Forest, in Vega Alta
- (w) Ensenada Forest, in Guánica
