PROPERTY REGISTRY OF PUERTO RICO

RULES AND REGULATIONS TO CREATE A NEW SECTION OF THE PROPERTY REGISTRY OF PUERTO RICO AT SAN SEBASTIAN AND TO AMEND THE RULES AND REGULATIONS OF THE PROPERTY REGISTRY OF PUERTO RICO TO MODIFY THE TERRITORIAL DEMARCATION OF THE PROPERTY REGISTRY OF PUERTO RICO, SECTIONS OF AGUADILLA, MAYAGUEZ AND UTUADO.

ARTICLE 1:- Pursuant to the power conferred upon the Secretary of Justice by Article 6 of Act No. 198 of August 8, 1979, as amended, a new Section of the Property Registry of Puerto Rico is created at the municipality of San Sebastián and the territorial demarcation of the Property Registry of Puerto Rico, Sections of Aguadilla, Mayaguez and Utuado is modified.

ARTICLE 2:- The seat of the new Section of the Property Registry shall be located on that municipality and its territorial demarcation shall comprise the municipalities of San Sebastián, Las Marías, Lares and Moca.

ARTICLE 3:- The Aguadilla Section of the Property Registry shall remain located on that municipality and its territorial demarcation shall comprise the municipalities of Aguadilla, Aguada, Rincón and Isabela.

ARTICLE 4:- All main and auxiliary books, drawing plans and other documents on file at the Aguadilla Section pertaining to the municipalities of San Sebastián and Moca shall be transferred to the San Sebastián Section of the Property Registry to form part of the files of the latter Section.

Article 5:- The Mayaguez Section of the Property Registry shall remain located on that municipality and its territorial demarcation shall comprise the municipalities of Mayaguez, Añasco and Hormigueros.


Article 6:- All main and auxiliary books, drawing plans and other documents on file at the Mayaguez Section pertaining to the municipality of Las Marías shall be transferred to the municipality of San Sebastián Section of the Property Registry to form part of the files of the latter Section.

Articles 7:- The Utuado Section of the Property Registry shall remain located on that municipality and its territorial demarcation shall comprise the municipalities of Utuado, Adjuntas and Jayuya.

Article 8:- All main and auxiliary books, drawing plans and other documents on file at the Utuado Section pertaining to the municipality of Lares shall be transferred to the Section of San Sbastián to form part of the files of the latter Section.

Article 9:- These Rules and Regulations shall go into effect thirty days after their publication in two newspapers of general circulation in Puerto Rico.
