TRAFFIC REGULATION FOR THE URBAN EXTENSION OF STATE ROUTE PR 37
(JOSE DE DIEGO AVENUE AND EUROPA STREET) IN SANTURCE, PUERTO RICO.

Article 1 - Authority

The Secretary of Public Works, by virtue of the powers vested on him by Section 17 (o) of Act No. 279, approved April 5, 1946, as amended, promulgates the following Regulation:

Article 2 - Application

The provisions of this Regulation shall apply to all types of vehicles, to their drivers and passengers, and to the pedestrians using the Urban Extension of State Route PR 37, in Santurce.

Article 3 - Definition

To the effect of this Regulation the term Urban Extension of State Route PR 37 shall mean that part of José De Diego Avenue included between Ponce de León Avenue and Loíza Street, and that part of Europa Street included between Ponce de León Avenue and Fernández Juncos Avenue.

Article 4 - Direction

Upon the urban extension of the State Route described in this Regulation, vehicular traffic may move in either direction twenty four (24) hours a day.

Article 5 - Parking Rules

(a) Parking upon Europa Street shall be governed by the following rules:

- 1- On the part included between Fernández Juncos Avenue and Ponce de León Avenue no person shall park a vehicle upon the roadway side of the east curb.
- 2- On the part included between Fernández Juncos Avenue and Asia Street no person shall park a vehicle upon the roadway side of the west curb.

(b) Parking upon José De Diego Avenue shall be governed by the following rules:

- 1- On the part included between Ponce de León Avenue and

Antonsanti Street no person shall park a vehicle upon the roadway side of the east curb and on the part included between Antonsanti Street and a point 48 meters to the north measured from the north curb of Antonsanti Street no person shall park a vehicle on the roadway side of the east curb from 7:00 A.M. to 8:00 P.M.

2- On the part included between Ponce de León Avenue and the south driveway to the Professional Building no person shall park a vehicle on any roadway side of the west curb from 7:00 A.M. to 8:00 P.M.

(c) On those places where parking is permitted, parking shall be limited to a maximum of one (1) hour during the period included between 7:00 A.M. and 7:00 P.M. except on Sundays and holidays.

Article 6 - Penalties


Any person who violates any of the provisions of this Regulation shall be punished according to the penalty provisions of Act No. 279, approved April 5, 1946, as amended.

Article 7 - Repeal

All existing traffic regulations or parts of traffic regulations inconsistent with the provisions of this Regulation are hereby repealed.

Article 8 - Time of Taking Effect

This Regulation shall take effect from and after the 23 day of December, 1957.
