TRAFFIC REGULATION FOR THE URBAN EXTENSIONS OF STATE ROUTES  
PR-116, PR-324, AND PR-325 IN GUANICA AND ENSENADA VILLAGE  
OF GUANICA, PUERTO RICO

Article 1- Authority

The Secretary of Public Works, by virtue of the powers vested on him by Section 12-101 of Act No. 141 (Vehicle Traffic Law of Puerto Rico), approved July 20, 1960, promulgates the following Regulation:

Article 2- Application

The provisions of this Regulation shall apply to all types of vehicles and to their drivers using the Urban Extensions of State Routes PR-116, PR-324, and PR-325 in Guánica and Ensenada Village of Guánica.

Article 3- Definitions

To the effect of this Regulation the following terms shall mean:

- (a) Urban Extension of State Route PR-116, that part of 25 de Julio Street included between Km. 28.30 and Silvestre Sebastián Rodríguez Street; plus that part of Silvestre Sebastián Rodríguez Street included between 25 de Julio Street and Yager Street; plus that part of Yager Street included between Silvestre Sebastián Rodríguez Street and the exit to Ensenada Village of Guánica; plus that part of this roadway included between Yager Street and Km. 27.75 in Guánica; plus that part of this roadway included between Km. 26.10 and Km. 24.00 in Ensenada Village of Guánica.
- (b) Urban Extension of State Route PR-324, that part of Montalva Road included between State Route PR-116 in Ensenada Village of Guánica and Km. 1.20.

- (c) Urban Extension of State Route PR-325, that part of Principal Street included between State Route PR-116 in Ensenada Village of Guánica and Verdún Street.

Article 4- Direction

Upon the urban extensions of the State Routes described in this Regulation, vehicular traffic may move in either direction, except upon the following parts:

(a) PR-116

- 1- That part of Silvestre Sebastián Rodríguez Street included between 25 de Julio Street and Yager Street in which vehicular traffic shall move in one direction only, westbound.
- 2- That part of Yager Street included between Silvestre Sebastián Rodríguez Street and the exit to Ensenada Village of Guánica in which vehicular traffic shall move in one direction only, southbound.

Article 5- Parking Rules

Parking upon the urban extensions of these State Routes shall be governed by the following rules:

(a) PR-116

- 1- On that part of 25 de Julio Street included between Km. 28.30 and Silvestre Sebastián Rodríguez Street, no person shall park a vehicle upon the roadway side of the west curb.
- 2- On that part of Silvestre Sebastián Rodríguez Street included between 25 de Julio Street and Yager Street, no person shall park a vehicle upon the roadway side of the south curb.
- 3- On that part of Yager Street included between Silvestre Sebastián Rodríguez Street and the exit to Ensenada Village of Guánica, no person shall park a vehicle upon the roadway side of the east curb.

- 4- On that part of this roadway included between Yager Street and Km. 27.75, parking shall be done according to the signs and markings placed by the Secretary of Public Works.
- 5- On that part of this roadway in Ensenada Village of Guánica included between Km. 26.10 and No. 2 Street, parking shall be done according to the signs and markings placed by the Secretary of Public Works.
- 6- On that part of this roadway in Ensenada Village of Guanica included between No. 2 Street and State Route PR-324 (Montalva Road), no person shall park a vehicle from 7 AM - 7 PM upon the roadway side of the south curb.
- 7- On that part of this roadway in Ensenada Village of Guánica included between State Route PR-324 (Montalva Road) and Km. 24.00, parking shall be done according to the signs and markings placed by the Secretary of Public Works.

(b) PR-324

- 1- On that part of Montalva Road included between State Route PR-116 in Ensenada Village of Guanica and Km. 1.20, parking shall be done according to the signs and markings placed by the Secretary of Public Works.

(c) PR-325

- 1- On that part of Principal Street included between State Route PR-116 in Ensenada Village of Guanica and Verdun Street, parking shall be done according to the signs and markings placed by the Secretary of Public Works.

Article 6- Penalties


Any person who violates any of the provisions of this Regulation shall be punished according to the penalty provisions of Act No. 141 (Vehicle & Traffic Law of Puerto Rico), approved July 20, 1960.

Article 7- Repeal

All existing traffic regulations or parts of traffic regulations inconsistent with the provisions of this Regulation, are hereby repealed.

Article 8- Time of Taking Effect

This Regulation shall have legal effect immediately after its publication, pursuant to the provisions of Act No. 112, of June 30, 1957, in the Commonwealth of Puerto Rico Register, for the purpose of which an original and two copies in both Spanish and English shall be previously filed in the Department of State Office.
