Closed-file polling places established in various electoral precints.

The following resolution unanumously adopted by the Insular Board of Elections held at a meeting held on February 19, 1952 is hereby approved and promulgated according to Article 70 of Act No. 27 of August 30, 1950, which is in force by virtue of the provisions of Section 39 of Act No. 1 of July 3, 1951.

RESOLUTION

To establish closed-file polling places in various electoral precints for the poll to be held on March 3, 1952.

WHEREAS, it has been impossible to find adequate quarters for voting in closed-file polling places in many electoral precifits of Puerto Rico for the poll which shall be held on March 3, 1952;

WHEREAS, the Insular Board of Elections may choose to hold said poll under the closed-file plan, forming the lines at the entrance of the polling places, as approved in Sections 70 of Act No. 27 (Referendum Act) and 61-(a) and 61-(b) of the Election Law.
