A PROCLAMATION-

Special Session of the Legislature: Call

WHEREAS, various matters of public interest demand action by the Legislature;

NOW THEREFORE, I, LUIS MUÑOZ MARIN, Governor of the Commonwealth of Puerto Rico, by virtue of the authority in me vested by the Constitution, do hereby call the members of the Legislature for a session which will start on Tuesday, September 7th. at 10:00 A.M. at the Capitol, so as to consider the following matters, and adopt adequate measures for the attention of same:


- 1. To authorize the Land Authority of Puerto Rico to create subsidiary corporations; to amend paragraphs (a) and (b) and add paragraphs (c) and (d) to Article 2; to amend Articles 3A, 4, 5, 6, 8, 11, 11A and 32; add Articles 35B and 35C to Act No. 26 of April 12, 1941, known as the "Land Law of Puerto Rico", as amended; to transfer to the Land Authority of Puerto Rico all the properties, records and unexpended balances of appropriations, entries and other funds of the Agricultural Company of Puerto Rico; to provide for the payment of liabilities incurred by the Agricultural Company of Puerto Rico; to repeal Acts No. 31 of April 24, 1945 and No. 452 of April 25, 1946; to resolve that the Land Authority of Puerto Rico shall acknowledge accumulated leaves to certain employees. (S.495)
- 2. To authorize the Land Authority to carry on programs of agricultural development and promotion, and to utilize its lands in the most adequate manner under the provisions of the Land Law. (S. 509)
- 3. To authorize the Land Authority to establish a crop loan security system for the Proportional Profit Farms. (H.1260)
- 4. To establish a farm credit program, regulate its functions and to appropriate funds. (H.1210)
- 5. To authorize the establishment of investment companies and regulate their functions. (H.819)
- 6. To amend the Puerto Rico Mining Law, Act No. 9 of August 18, 1933, as amended. (S.499)

- 7. An act on municipal loans. (H.1178)
- 8. An act to authorize the assignment of accounts receivable. (S.100)
- 9. An act to regulate trust receipt transactions. (S.214)
- 10. To appropriate the sum of \$200,000 for public telephones in the rural zone. (S.J.R.605)
- 11. To appropriate \$75,000 to the Department of State to promote necessary relations between Puerto Rico and other countries. (H.J.R.1771)
- 12. To authorize the University of Puerto Rico to invest its permanent fund in operating expenses. (H 1152)
- 13. To appropriate the sum of \$25,000 to the Department of Education for the acquisition of a building.
- 14. To appropriate \$100,000 for the implementation of the Income Tax Act. (H.J.R. 1982)
- 15. To appropriate funds for a special election to be held in Representative District No. 12, composed of the Municipalities of Manati and Barceloneta.
- 16. To appropriate funds to facilitate the operations of the committees engaged in the survey for the fixing of wages to be paid to the laborers in Puerto Rico.
- 17. To appropriate funds to the Water Resources Authority for the installation of electric power lines in the Barrio Maton in Cayey. (S.J.R. 905)
- 18. To appropriate funds to the Department of Public Works for the construction of facilities for the San Juan District Engineer's Offices, and to authorize the Secretary of Public Works to acquire by purchase or condemnation all the properties deemed necessary for such purpose, and to authorize him to sell the lot of land whereon the District Engineer's office is now located, the lot being the property of the Commonwealth.
- 19. To appropriate funds for the purchase of land and subdivision of same in the municipality of Hormigueros, and to repeal the appropriation covered by Joint Resolution No. 125 of July 8, 1953, providing for the construction of a recreational plaza in Hormigueros. (S.J.R.892)
- 20. To amend the title and sections 1 and 2 of Act No. 291 of May 7, 1951. (H.J.R. 1694)
- 21. To amend the title and sections 1 and 3 of Act No. 308 of May 10, 1950(H.J.R. 1806)
- 22. To amend subdivision 47 of section 1 of Joint Resolution No. 125 of July 8, 1953. (H.J. R. 1920)
- 23. To authorize the Secretary of Public Works to utilize the unexpended balance of the appropriations covered by Act No. 292 of May 10, 1950, and by Joint Resolution No. 125 of 1953, in the completion of the new municipal slaughter-house of Arroyo. (H.J.R. 2282)

- 24. To convey to the Social Programs Administration the appropriation covered by Joint Resolution No. 115 of June 29, 1954.
- 25. To create the Model Housing Board. (H.1172)
- 26. To amend section 2 of Act No. 185 of May 15, 1941, as amended, and to appropriate funds.
- 27. To amend article 11 of Act No. 465 of May 15, 1947, as amended, and to appropriate funds. (H.1230)
- 28. To bring eminent domain proceedings in relation to those buildings where printing presses, machinery or material dedicated to publications of whatever nature are located. (S.338)
- 29. To establish a retirement system for the members of the judiciary. (S.455)
- 30. To amend article 79 of the Penal Code extending the prosecuting period for crimes committed by municipal officials. (H.1112)
- 31. To amend subdivision (a) of Section 60A; subdivision (c) (3) of Section 117; the tables for the withholding of the tax at source of wages in the case of wages applicable to daily or miscellaneous payroll periods, which form part of subdivision (d) (1) of Section 141 and subdivision (a) (10) of Section 272 of Act No. 91, approved on June 29, 1954, known as the "Income Tax Act of 1954."
- 32. To amend Act No. 232, approved on May 10, 1949.
- 33. To reenact sections 57, 60 and 76 and to repeal section 62 of Act No. 74, approved on August 6, 1925; as amended, known as the "Income Tax Act of 1924"; and to repeal paragraph 1 of subdivision A of article 2 of Act No. 235, approved on May 10, 1949. (H.1275)
- 34. To amend acts related with traffic problems.
- 35. To exempt retroactively from the provisions of Act No. 303 of April 12, 1946, the total or partial remission of debts or liabilities made by the United States of America in the liquidation of the properties of the Puerto Rico Reconstruction Administration or the Rehabilitation Commission, and the discounts made by this Administration in order to liquidate all debts contracted with the United States of America or through the aforesaid Administration or through the Rehabilitation Commission. (S.J.R. 914).
